THE TARGET POPULATION OF THOSE WE SERVE IS PEOPLE EXPERIENCING HOMELESSNESS IN BOULDER COUNTY WHO ARE WILLING TO WORK OR CAPTURE AN INCOME AND MEET WITH A CASE MANAGER ONCE PER WEEK. IN 2020, WE SERVED 669 UNIQUE INDIVIDUALS FOR A CUMULATIVE 6,310 NIGHTS OF SHELTERING. THROUGH OUR NAVIGATION PROGRAM WE WERE ABLE TO GET 51 PEOPLE INTO HOUSING.
